Investment companies set the pace as latest three months see 23 launches, chasing £3.5bn

Since December, 23 funds with a combined target gross asset value of €12.94bn have been launched, while one fund has reopened.

Investment companies have dominated by number with a total target gross asset value of €3.5bn. SICAVs and PUTs have followed with three each.

In terms of target sector, diversified funds have

dominated by number, with six launched over the past three months, targeting a total GAV of €1.51bn.

Five funds targeting the residential sector were launched, with a target GAV of €1.54bn, while four funds of funds were started, with a targeted total GAV of €910m.

Turning to target location, eight European funds have

been launched, with a further seven funds targeting single country UK. Three Nordic funds were launched.
